Farm with melon cultivation for export to the USA, the production is maintained seasonally between the months of November to May, it has a production area of 422.5 ha and some 440 employees are maintained to carry out the different tasks of the crop. Water from wells is used, stored in a reservoir and used to supply the water needs of the crop through the drip irrigation method, there is a chlorine dispenser installed in the water line for its potability . Fertilizer applications are made through the irrigation system and through fumigation equipment. At the time of the inspection, a tour of the cultivation areas is carried out, water sources, dining room, toilets, chemical storage are verified and interviews are carried out with available personnel. Irrigation and manual control of weeds were being carried out at the time of the visit.
