During the audit, the team observed various stages of growth for different varieties of Honeydew and Cantaloupe Melons. The Melons were grown using water sourced from the surface water, which was then pumped into a canal system for irrigation. A Furrow irrigation system was used on the farm. The in-house agronomist made decisions regarding plant protection products, which trained and licensed operators applied. The farm manager was responsible for the day-to-day management of the ranch, while Rosa Meza from the corporate office was responsible for food safety. The ranch was inspected alongside eight other ranches over two days, consisting of physical inspections and paperwork reviews of the surroundings and water sources.
