AUDIT EXECUTIVE SUMMARY:

The operation is dedicated to packing conventional melons, cantaloupe and honeydew varieties, for export to the United States. The fruit that is packed comes from the farms of the same operation, upon entering the plant it is unloaded into a recirculated water tank with free chlorine at 200 ppm (PCC), the fruit goes up an automated belt to go through a single-step water spray with free chlorine at 200 ppm with brushes (PCC), then it goes through another water spray with peracetic acid (Tsunami 100 at 80-100 ppm). The belt takes the fruit to the sorting area, where personnel select the fruit to discard that which does not meet standards; the discarded fruit is placed on the center belt, where it is automatically taken out of the plant, and is unloaded into trucks that remove it from the site. The selected fruit goes through a drying section (high pressure air) and then is manually separated by size for packaging. Cantaloupe is packed in bags that go inside cardboard boxes, honeydew is packed only in cardboard boxes; the bags are closed with rubber bands and the boxes are palletized. The finished fruit is taken to the cooling tunnels and then to the cold holding room, from where it is loaded into containers. All work areas were inspected, or, the areas of packaging materials and box assembly, tunnels and cold rooms, external areas, supplies warehouse, restrooms, dining room, etc.
